

# 1. Overview

The following gives you an overview of the screen components in EDAform:



# **Title**

The title will show the type of DC form, submission mode and last modified date for the current session.

e.g: EDAform (DC12) - Internet: 25-Oct-2005

# **Toolbar**

The toolbar consists of nine buttons with representative action icons. You may notice certain buttons are grayed out. It denotes that the function is currently unavailable. For instance, if the 'Print' button is grayed out, it means that you have yet to save the form and there is no available information for printing.

Ø	New	Click on the 'New' button to create a fresh development application form.
0	Open	Click on the 'Open' button to open an existing development application form.

<b>X</b>	Exit	Click on the 'Exit' button to exit the EDAForm program.
	Help	Click on the 'Help' button to launch the web browser which will provide access to the online help. The online help provides the access to download the installation guide and this user guide, explanatory notes on EDAform and other EDA related information.  This function requires access to the Internet.
<b>\$</b>	Fee	Click on the 'Fee' button to launch the web browser which will provide the access to the online fee calculator.  This function requires access to the Internet.

# **Application Info**

Application Info displays the information of the current development application form.

# **Screen Navigator**

Screen Navigator displays the different types of screens for this development application form. Click on the screen tab to display the relevant screen on the page area.


# **Page Area**

Page area displays the input fields for each screen. The fields are different from screen to screen and may also be different with different application types.

# 2. Creating a New Development Application Form

To create a new development application form, follow the steps below:

1. Click on the 'New' button at the toolbar.




- 2. You will be prompted to specify the file name of the new application form in the dialog box.
- 3. Choose the directory where you want to save your application form at the 'Save in' dropdown list if necessary. By default, your application form will be saved at the C:\Program Files\edaxf\My Projects\ directory.
- 4. Specify the filename at the 'File Name' field. (Note: it is not necessary to specify the file extension; system will automatically append the extension **.edf** to your filename).
- 5. Click 'Save' button on the dialog box. A new application form will be created according to the filename you have specified.
- 6. The <u>Type of Application Information</u> screen will appear. Fill in the application type information and click on the 'OK' button. Once you have clicked on the 'OK' button, you will not be able to make any modification to the 'Type of Application Information' screen. If you have made any mistakes, e.g. selecting a wrong application type, you can restart by creating a new application form again. Please refer to 'Type of Application Information' screen on how to fill in the screen.

# 3. Opening an Existing Development Application Form

To open an existing development application form, follow the steps below:

1. Click on the 'Open' button at the toolbar.



- 2. You will be prompted to specify the file name of the application form you wish to open in the dialog box.
- 3. Choose the directory where your application form is located from the 'Look in' dropdown list.
- 4. Choose the file to open and click 'Open' button on the dialog box.
- 5. Note: you can open only one application form at any time.

# 4. Saving a Development Application Form


To save a development application form, follow the steps below:

- 1. Click on the 'Save' button at the toolbar.
- 2. You will be prompted if there are errors detected, e.g. a mandatory field is not entered at a certain screen.

<u>Note</u>: you will be prompted only when you have entered some data for certain screen(s) and did not complete it or entered incorrectly. You have to correct the mistakes before you can save your form.



3 If there is no error and you did not complete all mandatory screens, a prompt (see below) will be displayed to inform you that the information is saved, but certain screens are not complete.



4 If there is no error and you have completed all the mandatory screens, you will get the following message.



Please ensure that you get the above message when saving your form so that your application will not be rejected by URA for incomplete form submission.

5 <u>Note</u>: You are advised to save the application form after filling in information for each screen.

# 5. Printing a Development Application Form

To print a copy of the development application form, follow the steps below:

- 1. Click on the 'Print' button at the toolbar.
- 2. You will see the following message.



This is to inform you that your printed form is based on the saved application form. If you have not saved your application form, you should cancel the printing and use the 'Save' button at the toolbar to save first before printing.

- 3. Click 'Yes' to print the form. The system will generate the print out in an html page using your web browser. You may then print from your browser for your own record or for manual submission.
- 4. Click 'No' to cancel the printing.

# 6. Closing a Development Application Form

To close an opened development application form, follow the steps below:

- 1. Click on the 'Close' button at the toolbar.

  Note: This function is available only when an application form is opened.
- 2. If you have not filled in all the required information, you will be prompted that the form is not complete and asked to confirm whether you want to close the form.



3. If you have filled in all the required information, you will be asked to confirm closing the form only.



- 4. Click 'Ok' button to close the form.
- 5. Click 'Cancel' button to cancel the closing of the form.
- 6. <u>Note</u>: if you have not saved your application form, you should click 'Cancel' button or you will lose your changes.

# 7. Exiting EDAForm

To exit from EDAform application, follow the steps below:

- 1. Click on the 'Exit' button at the toolbar.
- 2. If you currently do not have an application form opened, you will be asked to confirm exiting from the EDAform application.



3. If you currently have an application form open and you have not filled in and saved all the required information, you will be informed that the form is incomplete and asked to confirm whether you still want to exit.



4. If you currently have an application form opened and you have filled in all the required information and save your form, you will be asked to confirm the exiting from EDAform application.



- 8. Click 'Ok' button to exit from EDAform.
- 9. Click 'Cancel' button to cancel the exit.
- 10. <u>Note</u>: if you have not saved your application form, you should click 'Cancel' button or you will lose your changes.

# 8. Online Help

To open the online help file, click on the 'Help' button at the toolbar. You can get the help on the User Guide, Explanatory Notes, etc. You need to have Internet connection to access the online help.

Note: In addition to on-line help, tool tips are also provided where necessary.

# 9. Fee Calculator

To calculate the processing fee, click on the 'Fee' button at the toolbar to launch the fee calculator. You will need to have an Internet connection to access the fee calculator.


There are two fee calculator functions:

- Form-based fees calculator this function calculates the fee based on the inputs from user. You will be prompted for the required inputs for fee calculation.
- Fee Calculator for uploaded files this function calculates the fee based on the application form you created using the EDAform program. You only need to upload your application form and it will return you the required fee amount.

# 10. Screen - Type of Application Information

The information required on this page differs depending on the type of application form selected.

Enter the information on the screen and click 'OK' button to proceed with creating a new application form. Click 'Cancel' button to cancel creating a new application form.



# **Application Group**

Select the type of application groups.

# **Application Type**

Select the type of application that you want to submit. The list of application types appear is decided by the application group selected.

### **Submission Type**

Select 'New Submission' for fresh submission and fresh amendment submission to Written Permission granted earlier, otherwise select 'Resubmission'. Resubmission should only be selected for following up the submission of a Provisional Permission, a Written Direction, an Advice or Outline Permission.

# **Lodgment Type**

Lodgment Type will be enabled for the selected application type if applicable. Select the type of lodgment for this application.

## **Total Multiple Development Option**

Use this field to make a Multiple Development Option submission. You can submit up to three options (for the same application type) for new erection of buildings, outline


application for new erection of buildings, additions and alterations to existing buildings or change of use in a single application.

# **Copy information from previous EDAForm**

Browse and select the **edf** file if you want to copy information from the existing EDAform to create a new application form.

- This is a mandatory field for conservation building applications.

- Select 'Yes' if the proposal is a government project, otherwise select 'No'
- This will be displayed for all types of applications.

## Is proposal affecting a gazetted monument?

- This will not be displayed for conservation applications.

# Is subject site within Envelope Control Area?

- Select 'Yes' if the site is within an Envelope Control Area, otherwise select 'No'.





# 13. Screen - Mukim & Lot Details



- 1. Select 'MK/TS', enter the 'MK/TS Number', 'Lot Number' and select 'Part Lot indicator'
- 2. To add a new row for entering Mukim/Town Subdivision record, click on the 'Add Rows' button. A new empty row will appear.
- 3. To edit the existing record, just modify whatever values on the screen.
- 4. To accept the changes, adding new record(s) and modify the exiting record(s), click 'OK' button to save the changes.
- 5. To delete an existing record, tick the checkbox 'Click to Select' on the row of the record to be deleted and click the 'Delete' button.

#### MK/TS

- Select the MK/TS type of the subject site.
- This field is mandatory

### **MK/TS Number**

- Enter the MK/TS number.
- This is a 2-digit field. Please record with leading 0 if value is between '1' to '9'. e.g. 07, 24
- This field is mandatory.

## **Lot Number**

- Lot number refers to legal survey lot number.

- Only new lot number format is accepted
- This field is mandatory.

# **Part Lot Indicator**

- Please select 'Yes' if the subject site covers only part of the lot, otherwise select 'No'.
- This field must be completed if the lot number field is filled.
- This field is mandatory.

# 14. Screen - Site Address

Please enter the official address(es) of the subject site if there is/are address(es). The address(es) or house/unit numbers must be entered for Addition/Alteration and Change of Use applications, if available.



- Enter the information for the Site Address and click on the 'OK' button to add the record.
- 2. Click on the 'Cancel' button to abort the action.
- 3. To edit an existing site address record, click on the 'Edit' button. Make the relevant modifications and click on the 'OK' button
- 4. To add a new site address record, click 'Add' button. The S/No will be incremented. Enter information and click 'OK' button.
- 5. To delete an existing site address record, click on the 'Delete' button.
- 6. Click on the '<<' button to view the first site address record.
- 7. Click on the '<' button to view the previous site address record.
- 8. Click on the '>' button to view the next site address record.
- 9. Click on the '>>' button to view the last site address record.

## **Building Name**

- Record the name of the building for the development site, if available.

- Please spell it in full, e.g. International Plaza.

## **Road Name**

- Record the 'Road Name' from the list provided in the system
- To search for a road name, you may:
  - Click on the image to bring up the Road Search function and type in 1<sup>st</sup> few characters of the road name to search or
  - If the road name to be recorded is not found in the list (e.g., new road yet to be listed), record it in the 'Locality Description' field as an additional information. Refer to Locality Description for example.

### **House/Block No**

- Record 'House/Block Number' without prefix such as 'Blk', 'Hse No', or 'No'. E.g. for Blk 205 record as 205
- Omit full stop `.', dash `-` or space between numeric and alpha character. E.a.

for House No 5-A record as 5A

for House No 34 C record as 34C

for Blk No 8.H record as 8H




#### **Declaration requires user to tick the declaration item**

Some declaration requires user to tick the declaration item to declare because it is an optional item. If you see a box besides a declaration text, make sure you click on it if you agree to the stated declaration and click 'I Agree' button again to take in the changes.



#### **Declaration for lodgment submissions**

Declarations for lodgment applications display the schedule info before the declarations. For each item in the schedule, set the radio button to 'Yes' or 'NA'("NA" for Not Applicable). Scroll down to see the rest of the items. Click "I Agree" button to agree with the declaration stated.



For change of use lodgment submission, the declaration text is dynamic. It depends on the type of lodgment category and development type selected in the Site Address Lodgment screen.
