#### URA/PCUD PLAN RELEASE 1/2016E REVISED STREET BLOCK PLAN FOR UPPER CIRCULAR ROAD CONSERVATION AREA (SINGAPORE RIVER PLANNING AREA)

1. This circular provides information on the revised platform levels for the covered walkways fronting certain stretches of the roads within Upper Circular Road Conservation Area. The revision will achieve a more seamless pedestrian experience by minimising the level differences between the open and covered walkways as well as within the covered walkways between adjacent developments. The Upper Circular Road Conservation Area is bounded by Upper Circular Road, North Canal Road, New Bridge Road and South Bridge Road, as shown in <u>Appendix 1</u>.

### Covered Walkways

- 2. This circular provides information on the revised platform levels for the covered walkways fronting certain stretches of the roads within Upper Circular Road Conservation Area. The revision will achieve a more seamless pedestrian experience by minimising the level differences between the open and covered walkways as well as within the covered walkways between adjacent developments. The Upper Circular Road Conservation Area is bounded by Upper Circular Road, North Canal Road, New Bridge Road and South Bridge Road, as shown in <u>Appendix 1</u>.
- 3. To minimise level changes, the platform levels of the covered walkways should be guided to match the adjacent open walkways as far as possible. However, for certain stretches where the covered walkways cannot be raised to match the open walkways, the covered walkways are to match each other at the stipulated platform levels as shown in <u>Appendix 2</u>.
- 4. This street block plan will be used to guide addition & alteration works and redevelopment proposals within Upper Circular Road Conservation Area.
- 5. The other planning parameters and guidelines covered by this street block plan remain unchanged and include the type of land use, building height, form of development, building edge, covered walkway requirements and vehicular access. Buildings under conservation gazette are required to comply with the detailed conservation guidelines for the area. The prescribed guidelines are tabulated and shown in <u>Annex A</u>.

# STREET BLOCK PLAN FOR UPPER CIRCULAR ROAD CONSERVATION AREA (SINGAPORE RIVER PLANNING AREA)

The purpose of this street block plan is to guide addition & alteration works and redevelopment proposals within Upper Circular Road Conservation Area to ensure that developments have a strong street edge and contribute to the planned comprehensive continuous covered walkway network for comfortable pedestrian movement at street level.

The prescribed planning parameters and urban design guidelines for the street block plan are set out below.

				walkway being increased to match the higher height. This is to ensure adequate weather protection for pedestrians during inclement weather.
		The platform level of the covered walkway is to be adjusted to match the levels as indicated in Appendix 2. These levels serve as a guide, and are subject to final site survey.		
		Where there are differences in level with the adjacent open walkways or the covered walkways of abutting developments, ramps must be built to mediate the differences. Steps are only allowed for steep gradients where ramps are not possible; and		
		Where there is a level difference between the covered walkway and the 1st storey of the development, ramps or steps between the two levels must be built within the 1st storey level of the development and not along the covered walkway.		
		For 27 New Bridge Road, the level of the covered walkway is to match the adjacent walkway as much as possible, without obliterating the relief/artwork on columns of the conserved building.		
8	Roofscape	The roofscape must be restored in accordance with the relevant Conservation guidelines.		
		Units 27, 29, 31 & 33 New Bridge Road shall have the entire main pitched roof conserved.
